Regarding 7.Section 15 amended (category B firearms licence) does this mean that all future sales of lever action shotguns will be recorded as a Cat B firearm ?

Also there are various makes of shotguns in lever action, straight pull and lever release with a magazine capacity of over five rounds and so what is the situation in regard to any action shotgun that exceeds five rounds.(and up to ten rounds)

On another aspect what happens to the current owners of shotguns (of the actions mentioned above) that have a capacity greater than five rounds with these being at present registered as a Cat A3 firearm ?

16. Section 149 amended (disposal of surrendered or seized firearms) - At times in the past we have been handed good order unregistered firearms and left to destroy or sell the firearm whatever we consider appropriate and so

may we continue to register these if they are considered safe to use ?
